**CONDITIONS OF APPLICATION**  
FOR **DOG WALKING PERMIT** AT FAERIE GLEN NATURE RESERVE

1. The permit will be carried with person at **all times** while walking dog in reserve
2. Permit must be produced on request by authorized persons
3. The **permit is not transferable** and only for use by person indicated on the permit
4. The ID photo must be a new photo, (Not a copy thereof, **nor one cut out from the old permit**)
5. Start date of the permit will be the same month in which the permit was purchased
6. Only **persons 16 years of age and older** may apply for a permit
7. No more than **two** dogs allowed per permit
8. Dogs must be on a leash **at all times** as per public amenities bylaw
9. **Dog excreta must be removed** and disposed of in bins provided. Plastic bags are supplied by **Friends of the Faerie Glen Nature Reserve** and available at the entrance
10. Dogs and their owners must **stay on existing paths**
11. Owners must keep dogs at a **reasonable distance** of at least 50 metres from game and give game and people without dogs right of way
12. No bitches on heat are allowed

**PROCEDURE FOR APPLYING FOR PERMIT**  
**(PERSON APPLYING MUST BE 16 YEARS OR OLDER)**

1. Application form can be obtained at

  - \* Email – [admin@fgnr.co.za](mailto:admin@fgnr.co.za)
  - \* At the main entrance of Faerie Glen Nature Reserve
2. Application form to be completed and handed in at cashier point together with
  - \* Copy of ID (not necessary to be certified)
  - \* One original ID photo
  - \* Receipt from permit application payment
3. Applicant will sign the register as proof that the application form was submitted
4. Permits will be available at the Faerie Glen NR cashier point after approximately 3 working days
5. Applicant will sign the register as acknowledgement of receipt of permit
6. The permit will be valid for one calendar year. Permit amount will increase at the 1<sup>st</sup> of July each year as per published government gazette
7. If the permit wasn't collected, it will be destroyed after its expiry date
